University Health Services (UHS)

Information about Services:

• Students come to UHS for all medical conditions. UHS has seven physicians, four of whom are also fellowship trained sports medicine physicians, and three nurse practitioners to see both undergraduate and graduate students. Conditions include general illness, women's health, men's health, musculoskeletal problems, disordered eating, annual physical exams, chronic disease management, and travel consultations. UHS also employs a full-time medical dietitian that works collaboratively with our eating disorder task force and manages students who have medically related nutrition needs. UHS offers point-of-care testing, such as urgent care, and also makes available Mass General Brigham (MGB) X-Ray on campus, as well as point-of-care musculoskeletal ultrasound performed by our sports medicine physicians. If a student needs a referral to a specialist outside of UHS, we typically use the MGB referral network; however, we can refer to any provider outside of this network as well.

Hours of Operation:

- UHS is one of five universities in the United States that offers 24-hour care to its student population. We have a 10-bed infirmary that serves as more respite care for students that are too sick to stay in their residence hall, but not sick enough to present to the hospital. The infirmary also offers post-operative care once discharged from the hospital and a safe and private area for our students who need to speak with the psychiatric emergency clinician (PEC) once University Counselling Services closes for the day. There is a provider on-call for the infirmary every night, including weekends. The weekend provider also sees patients on Saturday and Sunday for two hours each day when on-call, scheduled by the infirmary nursing staff.
- The outpatient clinic is open Monday through Friday 8:00 am until 5 pm during the academic year. UHS offers same day appointments for students on a first-come, first-served basis.

Eligibility:

- Full-time students enrolled in degree programs are eligible for all UHS services. All undergraduate students pay the student health fee in accordance with their tuition. UHS does not bill insurance, so all BC-related services are part of this student health fee and students are not charged. External services on campus send a bill to your insurance plan. These external services include phlebotomy (LabCorp), durable medical equipment (DME), and X-Ray services (MGB). Graduate students may opt to pay the student health fee and have the same services as undergraduate students above. Graduate students who opt to not pay the fee will be charged for their visits and will receive a receipt for each visit to send to their insurance company for reimbursement. UHS is not responsible for denials of claims from private insurance.
- All students at Boston College are required to have health insurance that covers their services in Massachusetts. Please note that out of state Medicaid does not cover someone in Massachusetts. Boston College offers a health insurance plan (separate from the health services fee) that provides coverage for medical and mental health services. This health insurance plan is NOT required for students provided that the student has valid insurance that meets Massachusetts requirements.

Information about Services:

- Students come to University Counseling Services (UCS) for a variety of problems and concerns. Students can request a Same Day Consultation (SDC) for a solution-focused consultation session to address a specific concern or an intake appointment for traditional therapy. During that time the student and a clinician will work together to determine what might prove most helpful to the student. Most students seeking therapy will engage in brief individual (average of 6-8 sessions) or group psychotherapy at UCS. Students needing ongoing, weekly therapy or specialized care may be assisted in finding appropriate referrals off-campus.
- Please be ready to begin your appointment on time as we will not be able to extend the session`time due to lateness. Individual sessions are typically 45 minutes. Students are expected to make every effort to cancel appointments 48 hours in advance so that another student in need of an appointment can use that time slot. If more than three appointments are missed, we will need to reassess your treatment needs.

Hours of Operation:

- UCS is open from 8:45 a.m. to 4:45 p.m. for appointments, Monday through Friday, except on University holidays. The Psychological Emergency Clinician (PEC) is available during regular office hours for urgent mental health concerns, and can be contacted by either calling 617-552-3310 or walking into our offices. PEC is also available after hours and on weekends for psychological emergencies that require immediate attention and cannot wait until regular office hours.
- Students can contact the PEC by calling 617-552-3310 and pressing option 2 to reach the emergency clinician.

Eligibility:

• Full-time students enrolled in degree programs are eligible for all UCS services. Part-time or non-matriculating students (including those on dissertation status, on leave of absence or in special programs) are only eligible for consultation and referral, if appropriate. Students seeking an evaluation for medication should be advised that UCS is only able to provide this service to those who are also engaged in ongoing psychotherapy with a UCS clinician. We can help you with a psychiatry referral off campus if you are interested in medication only. UCS does not provide mandated or court ordered therapy, psychological testing, or evaluation for emotional support animals as each of these are beyond the scope of services.

Involvement in Administrative Actions:

• Students sometimes come to UCS requesting intervention on their behalf in response to academic or disciplinary difficulties. As a matter of policy, UCS does not intervene in administrative decisions regarding individual students. On occasion, students are requested by certain University officials (e.g. Dean of Students) to meet for a consultation with a clinician. In these cases, the clinician would, with the written consent of the student, report back to the referring administrator regarding the general issue for which the referral was made. However, the clinician would not share detailed clinical information about the student with an administrator.

Staff Supervision and Consultation:

• The staff of UCS is comprised of professionals with differing areas of expertise, and includes those who work under the supervision of licensed senior staff. To provide you with the best service possible, we may discuss your situation with other staff members of UCS. In addition, some information is collected and used to carry out administrative tasks. All information shared among these professionals is treated as confidential.

Telehealth Services:

- Both in-person and telehealth services will be offered. Many students find the flexibility enhances their access to support. The appropriateness of telehealth vs. in-person sessions is something you will discuss when making your appointment and with your clinician ongoing. Based on licensure regulations, students must be in Massachusetts when accessing telehealth appointments. There may be times when your clinician deems it clinically necessary to use one mode of delivery or the other to best provide your care.
- If you are ill, even if experiencing mild symptoms, please call the office to either reschedule or to switch your inperson appointment to telehealth. There will also be times that if your clinician is ill or out of the office, you may be notified of the need to switch to telehealth delivery or to reschedule.

Informed Consent for Telepsychology:

• This section contains important information focusing on doing psychotherapy using the phone or the Internet. Please read this carefully and let UCS staff know if you have any questions.

Benefits and Risks of Telepsychology:

- Telepsychology refers to providing psychotherapy services remotely using telecommunications technologies, such as video conferencing or telephone. One of the benefits of telepsychology is that the client and clinician can engage in services without being in the same physical location. This can be helpful in ensuring continuity of care if the client or clinician moves to a different location, takes an extended vacation, or is otherwise unable to continue to meet in person.
- Telepsychology also may ensure continuity of care during public health emergencies in which physical distancing is advised, therefore protecting the health of both the client and clinician and allowing for better non-verbal communication. Telepsychology, however, requires technical competence on both our parts to be helpful. Although there are benefits of telepsychology, there are some differences between in-person psychotherapy and telepsychology, as well as some risks.

For example:

- Risks to Confidentiality: Because telepsychology sessions take place outside of the therapist's private office, there is potential for other people to overhear sessions if you are not in a private place during the session. UCS staff will take reasonable steps to ensure your privacy. It is equally important that you make sure to find a private place for sessions where you will not be interrupted. It is also important for you to protect the privacy of sessions on your cell phone or another device. You should participate in therapy only while in a room or area where other people are not present and cannot overhear the conversation.
- Issues Related to Technology: There are many ways that technology issues might impact telepsychology. For example, technology may stop working during a session, other people might be able to get access to private conversations, or stored data could be accessed by unauthorized people or companies.
- Crisis Management and Intervention: Usually, UCS will not engage in ongoing telepsychology with clients who are currently in a crisis requiring high levels of support and intervention. Before engaging in telepsychology, we will develop an emergency response plan to address potential crisis situations that may arise during our telepsychology work.
- Efficacy: Most research shows that telepsychology is about as effective as in-person psychotherapy. Some therapists believe that in some situations something is lost by not being in the same room. For example, there is debate about a therapist's ability to fully understand nonverbal information when working remotely. Inversely, therapy while wearing masks in the same room can impede both verbal and non-verbal communication and, in some situations, may be less effective or desirable.

- You and your clinician will decide together which kind of telepsychology service to use. You may have to have certain computer or cell phone systems to use telepsychology services. You are solely responsible for any cost to you to obtain any necessary equipment, accessories, or software to take part in telepsychology.
- For communication between sessions, UHS and UCS staff only use secure messaging through the agora portal, email communication and text messaging with your permission and only for administrative purposes unless you and your provider have made another agreement. This means that email exchanges with UCS should be limited to administrative matters. This includes things like setting and changing appointments and other related issues. You should be aware that UCS cannot guarantee the confidentiality of any information communicated by email or text. Therefore, UCS will not discuss any clinical information by email or text, and prefer that you do not either, unless using the student health portal or a secure email service such as Virtru. Also, clinicians do not regularly check email or messages, so these methods should not be used if there is an emergency.
- Treatment is most effective when clinical discussions occur at your regularly scheduled sessions. But if an urgent issue arises, you should feel free to attempt to reach your clinician by phone. Your clinician will try to return your call within 24 hours except on weekends and holidays. UCS maintains an emergency clinician to respond to clinical emergencies. If you are unable to reach UCS and feel that you cannot wait for UCS to return your call, contact your physician or the nearest emergency room and ask for the psychologist or psychiatrist on call. If your clinician will be unavailable for an extended time, you will be provided with the name of a colleague to contact if necessary.

Telepsychology Confidentiality:

UCS has a legal and ethical responsibility to make best efforts to protect all communications that are a part of
telepsychology. However, the nature of electronic communications technologies is such that UCS cannot
guarantee that our communications will be kept confidential or that other people may not gain access to
communications. UCS will try to use updated encryption methods, firewalls, and back-up systems to help keep
your information private, but there is a risk that electronic communications may be compromised, unsecured, or
accessed by others. You should also take reasonable steps to ensure the security of our communications (for
example, only using secure networks for telepsychology sessions and having passwords to protect the device you
use for telepsychology).

Appropriateness of Telepsychology:

• Your clinician will let you know if they decide telepsychology is no longer the most appropriate form of treatment for you. They will discuss options of engaging in in-person counseling or referrals to another professional in your location who can provide appropriate services.

Emergencies and Technology:

• Assessing and evaluating threats and other emergencies can be more difficult when conducting telepsychology than in traditional in-person therapy. To address some of these difficulties, you and your clinician will create an emergency plan before engaging in telepsychology services. Your clinician will ask you to identify an emergency contact person who is near your location and who they will contact to assist in the event of a crisis or emergency. If the session is interrupted for any reason, such as the technological connection fails, and you are having a life-threatening emergency and cannot wait for a call back, do not call your clinician back; instead, call Boston College Police Department at 617-552-4444, call 911, or go to your nearest emergency room. Call your clinician back after you have obtained emergency services. If the session is interrupted and you are not having an emergency, disconnect from the session and wait a few minutes while your counselor re-contacts you via the telepsychology platform. If you do not receive a call back within a few minutes, then call our office number (617-552-3310). *Telepsychology Records:*

• The telepsychology sessions shall not be recorded in any way unless agreed to in writing by mutual consent. UCS will maintain a record of sessions in the same way it maintains records of in-person sessions in accordance with its policies

Health Records: Confidentiality and Access

- Like all comprehensive medical practices, the Murray Center for Student Wellness keeps records of your contacts with us. We have an electronic health record system that is shared by University Health Services and University Counseling Services. Your health records are treated as private and confidential in accordance with applicable law. Absent a legal exception, access to student *mental* health records maintained by the Murray Center's health record system is limited to UCS practitioners and UHS physicians and nurse practitioners, and these UHS and UCS providers use these records solely for the purpose of treatment and coordination of care for that student, unless the student specifically consents that records be shared with other providers or shared for another purpose. Your other health records may be shared with UHS providers and other health care personnel involved in your care outside of UHS, and outside of the University when you are referred for outside care and as may be required by law or in connection with your consent or request.
- Outside of the Murray Center for Student Wellness, UCS will release information regarding a student's use of the services or personal information only if the student signs a written authorization that meets legal requirements, or in certain rare circumstances which legally require us to disclose this information regardless of the client's authorization. A student may authorize UCS to release records or to disclose other information to individuals of the student's choosing. The following situations do not require the authorization of the student:
- Child Abuse: If we, in our professional capacity, have reasonable cause to believe that a minor child is suffering physical or emotional injury resulting from abuse inflicted upon him or her which causes harm or substantial risk of harm to the child's health or welfare (including sexual abuse), or from neglect, including malnutrition, we must report such conditions to the appropriate state department of social services.
- Adult and Domestic Abuse: If we have reasonable cause to believe that an elderly person (age60 or older) is suffering from or has died because of abuse, we must make a report to the appropriate state department of social services;
- Health Oversight: The licensing authorities of the professions represented in UCS have the power, when necessary, to subpoen relevant records should any clinician be the focus of an inquiry;
- Judicial or Administrative Proceedings: If you are involved in a court proceeding and a request is made for information about your diagnosis and treatment and the records thereof, such information is privileged under state law and we will not release information without written authorization from you or your legally-appointed representative, or a court order; and
- Serious Threat to Health or Safety: If you communicate to your clinician an explicit threat to kill or inflict serious bodily injury upon an identified person and you have the apparent intent and ability to carry out the threat, we must take reasonable precautions. Reasonable precautions may include warning the potential victim, notifying law enforcement, or arranging for your hospitalization. We must also do so if we know you have a history of physical violence, and we believe there is a clear and present danger that you will attempt to kill or inflict bodily injury upon an identified person. Furthermore, if you present a clear and present danger to yourself and refuse to accept further appropriate treatment, we have an obligation to take reasonable actions to ensure your safety. These actions could include involuntary hospitalization or notifying your family or others who could assist in protecting you.

- When a student requests a copy of the student's health records, any medical notes are reviewed by University Health Services, and any mental health records and notes are reviewed by University Counseling Services, before the records are released to the student.
- Counseling records may include reasons for consulting with UCS, diagnosis (if appropriate), counseling goals and progress toward those goals, client's social and medical history, any past treatment records received from other providers, and notations of any professional consultations. Clients may examine and/or receive a copy of their clinical counselling record, if requested in writing, unless the clinician believes that such access might be harmful to the client. In those situations, clients have a right to a summary and to have the record sent to another mental health provider or to a designated legal representative. Due to their content, clinical records can be misinterpreted and/or be upsetting to untrained readers. Accordingly, we typically recommend that clients should review their records in the presence of their clinician.
